06/13 Matters arising out of the minutes 17th April 2013 Minute Reference 157/12 – Link Bus Trial

JR reported that the Link Bus had been discussed at the Laxey Regeneration meeting on 24th April 2013. JR briefed the Commissioners summarising the situation explaining that MNH was unable to offer funding this year and LVC and L&LHT had reiterated their potential support however Tours (IOM) reported a loss last season of approximately £5,000 which made the service unviable. JR stated the offer form Tours Isle of Man of providing a 'free' mini bus to be run by other had been discussed and it had been agreed that it was not viable to run a service using a non coach operator, however further consideration would be given to feasibility of running the link bus next year. JR reported that Peter Maddocks from the DCCL had been at the meeting and reported on the Rose Gardens/Village Square and MER station scheme. JR said PM had advised there were budget issues which were delaying the MER station scheme and they were looking to split the scheme into two elements and that the drawings would need to be amended to allow the split and that this may require the submission of a revised planning application. AM reported the Link bus had also been discussed at the Laxey and Lonan Heritage Trust.

- f) Joan.Gleave@gov.im e-mails at 1646 hours on 22.04.13 the following, 'In line with Government's Agenda for Change programme and in particular its policy to reduce bureaucracy, the Civil Service Commission has launched a public consultation on the proposal to establish a Public Services Commission (PSC). This follows the Chief Minister's announcement on 15 March 2013 that there would be a consultation on creating a PSC to modernise Government's employment structures. It is intended that the PSC would be the employing authority of not only civil servants, but also other categories of employee including manual and craft workers employed under Whitley Council terms and conditions, and some other employees across central Government; principally those whose terms and conditions are analogous to the Civil Service or the Whitley Council. This would account for approximately 4,000 staff which is about half of all central Government staff. The consultation document poses questions regarding employment groups to be included; negotiating mechanisms; implications for local authority employees and the concept of new terms and conditions for new starters. The Chairman of the Civil Service Commission, Alfred Cannan MHK said: 'It is important that we move forward with a single employing authority. I would therefore encourage all interested
