Mr Sabey provided photographic evidence to the Board showing that casement windows had previously been installed in the property. **26/14 Approval of Minutes**

Minutes of Monthly Meeting held on 11<sup>th</sup> June 2014 were examined for accuracy, and it was unanimously resolved they represented a correct statement of events.

**27/14 Matters arising out of the minutes 11<sup>th</sup> June 2014.**

a) Village notice Boards. Deferred to meeting 16.07.14.

b) Minute Reference 13/14, item d) and 20/14, item b). White railing between Mines Road and Princes Motors.

*The Clerk reported that replacement railings had been manufactured and were currently stored in the Blacksmiths yard, however it was not known if and when they would be installed.*

c) Minute Reference 24/14, item g). Glen Gardens Pavilion.

The Clerk circulated an email dated 02.07.14 from Richard Lole Chief Executive Officer at Department of Environment, Food and Agriculture, in respect of the Laxey Glen Pavilion. Mr Lole states the property will be advertised in the next few weeks with two main opportunities being available. The more standard opportunity is to offer the Pavilion building on its own, as has been the norm over the years. There will also be an opportunity for organisations to consider renting the majority of the Glen area along with the Pavilion with a view to opening the area up to groups or organisations that would require open space for their activities or have an interest in the area.

*Resolved to note.*

**28/14 General correspondence**

a) Letter of 16.06.14 from Lonan, resident concerning obstructions in Pinfold Hill and South Cape. She is finding it difficult to walk along the footway at Pinfold Hill, (LPC) due to overhanging growth from the adjoining properties, (Note: Annual occurrence), and also the location of the litter bin at the bus stop at South Cape, (LVC) partially obstructs the pavement. Please could something be done about this.

*The Clerk advised the litter bin had now been moved. A discussion took place and it was noted that 2 properties on New Road between Old Laxey Hill and the Queens Hotel had overgrown vegetation partially obstructing the pavement.*

b) Alan Jones of Douglas Borough Council emails at 1226hrs on 19.06.14. A number of local Authorities attended a presentation from the Chief Constable about his reorganisation of the Constabulary. I would be grateful if the attached discussion document could be circulated to members of the Association. I will be proposing that Peel Commissioners raise serious concerns about the effect of the cuts on the ability of the Police to do their job. The Document is just a quick response to the presentation and I am sure that others could and will wish to amend or add to it – especially some of my former colleagues in the Force! I would ask that the Municipal Association (after Consulting their respective boards) submit a letter of concern about the cuts.

*RB reported she had attended the Police Constables Presentation along with JP. A detailed discussion took place with respect to reduction in police staff levels and the potential impact on policing in Laxey and surrounding area. JP reported that multi agency professional hubs were to be set up to deal with*

*persistent offenders and that more technical resource was required to deal with internet fraud and cyber bullying. A discussion took place in respect of night cover policing and response times. A consensus was reached that there was a lot of conjecture and not enough detailed information contained within the Chief Constables presentation. A further discussion took place and it was Resolved the Clerk write to the Chief Constable expressing concerns as to the impact of the proposed changes, seeking detail of any potential impact the changes may have on policing in the village.*

- c) Consultation on the Criminal Procedure and Investigation Bill 2014 which is to provide for a statutory framework within which the prosecution are to disclose unused material in criminal prosecutions and to provide further information on the basis of the statement of case made by the accused. Submissions before Tuesday 24<sup>th</sup> July 2014.

- d) Laxey Campsite Quality Grading Report dated May 2014. See attached Blue Papers. *AM proposed a vote of thanks to the Campsite Warden John Bate and proposed any improvements highlighted within the plan should be implemented as soon as possible. It was Resolved that the recommended improvements suggest in the report would be undertaken after the site closes at the end of September.*

## 29/14 **Committee Reports**

- a) **Municipal Association** – Roz Bate – *RB reported that Mark Henthorne of the Isle of Man Astronomical Society had given a presentation on ‘Dark Skies & Street Lighting’ and that a detailed discussion had taken place in respect of the recent Chief Constables presentation and proposed changes to the Isle of Man Constabulary.*

- e) **Garff Joint Initiative Committee** – Roz Bate, Vacancy, meeting 30.06.14. *AM reported that he had attended the meeting with RB. Mr Chris Robertshaw MHK, Mr Richard Ronan MHK and Mr Steve Rodan MHK were in attendance along with government officers and overall the meeting had been very positive it was clear that the Government fully supported the proposal in principle to form a Garff Board. RB reported that discussion had taken place in respect of the points outlined previously including ring fencing monies identified for specific project in Laxey, Lonan and Maughold to ensure they would be used for their intended purposes following the proposed merger of the three Authorities. AM stated that Steve Rodan MHK had raised the matter of Local Authority Assets in respect of the property and land, in particular to Laxey as it had significant more than Lonan or Maughold. AM said that Mr Rodan stated that members needed to anticipate the concerns of residents in these matters as there was potential for disgruntlement in regard to facilities funded from across Garff, but installed in a specific area. A discussion took place with respect to property owned by Laxey Village Commissioners. The Clerk advised that as a requirement of SORP in respect of Local Authority Accounts a valuation has to be carried out every 5 years, the next one due to be completed by 31<sup>st</sup> March 2015. It was Resolved the Clerk circulate the 2010 valuation report to the Commissioners.*

### 30/14 **Chairman's Report**

- a) AM proposed a vote of thanks to the Clerk and Laxey Fair Committee for the efforts organising this year's Laxey fair and in particular Mrs Ward of Laxey School who had provided excellent refreshments for the VIP reception.

### 31/14 **Any Other Business**

- a) Civic Service – Consideration as to if and when the Commissioners Civic Service takes place this year. By rotation this year's service will be at Christ Church and normally takes place late September early October.  
Please note Lonan Commissioners Civic Service is on Sunday 5<sup>th</sup> October.  
*AM proposed that this year Laxey would not hold a Civic Service. A discussion took place and it was resolved there would be no Civic Service this year. Propsoed AM, Seconded JJ.*
- b) Garff Carol Service - Last year's service was postponed due to Christ Church being closed for refurbishment. Consideration to be give as to whether Laxey host the service or by rotation it goes to Lonan Commissioners. Please note the Lifeboat and Carol service will be at Christ Church this year.  
*A discussion took place and it was resolved AM would contact the Rev Jo Dudley to discuss possible options for combining the two events.*
- c) DED Road Races e-mails at 1541 hours on 27.06.14 - The Department of Economic Development considers that there may be significant benefit in scheduling an additional qualifying session on Saturday 23<sup>rd</sup> August 2014 to provide competitors more opportunity to practice, qualify and prepare their machines prior to the scheduled commencement of racing. The Department invites views on the proposal which will result in an additional 2.5 hour road closure on Saturday 23<sup>rd</sup> August commencing 0930. I have pleasure in attaching a link to the consultation paper for your consideration. Responses may be submitted by post or email. *RB stated she thought they would struggle to find enough Marshalls a discussion took place and it was resolved to defer to the meeting 16.07.14.*
- d) Pat Burgess of Lossan y Twoaie, Glen Road, Laxey, IM4 7AN writes on 27.06.14 regarding PA 14/00335/B. She rebuts and claims inaccuracies in Laxey Commissioners' planning objections.  
*JJ advised that the Board had objected to the planning application in April this year and that the application was with the inspector pending his report and decision. AM invited Mrs Burgess to address the Board. Mrs Burgess stated that the minutes of the meeting 16.04.14 were incorrect because they stated a planning submission had been prepared by Cains Advocates for Mr & Mrs Williams in respect of PA 14/00335?B. AM advised that this was correct and the submission was an objection to the proposed development. Mrs Burgess when on to say that the minutes also stated that the development reduces the amenity of Cliff Cottage by taking away the garden, when in fact the Cliff Cottage was not owned by the applicant. The site of the proposed development had been part of Cliff Cottage but was now a separate parcel of land and therefore there was no loss of garden to Cliff Cottage. AM thanked Mrs Burgess for her comments.*

The consultation seeks to gather views on the Island's current regime for identifying the beneficial ownership of companies, and whether a centralised registry of such information would improve transparency. As well as providing background, the consultation document poses a wide range of questions covering various aspects of the issue including availability of information held by a centralised registry if one were introduced. The consultation is in line with the commitment given by the Isle of Man Government in its G8 Action Plan, published last year, that it would conduct an assessment of its beneficial ownership regime including consideration of a centralised registry. *The Clerk reported he had contacted both the Office of Fair Trading and the Department of Environment Food and Agriculture Food Safety unit regarding this request. The OFT had no concerns as long as the vendor was a Manx Resident and that all prices should be clearly displayed. The Food Safety Unit had advised inspections would need to be undertaken of the premises where the ice cream is made and the vehicle used for vending and approval of method statements. A discussion took place and it was Resolved to approve the request. It was noted that the vendor would need to seek permission from the Manx Electric Railway with respect to vending at the tram station.*
