#### 120/15 Planning Matters

## **Planning Applications**

- a) Planning application no. 16/00035/B, in respect of Construction of a new bridge over Laxey River with refurbishment of section of road to both sides of bridge, including re-surfacing of road, realignment and re-paving of footpaths and installation of lighting. Laxey Bridge Glen Road Laxey Isle Of Man. LVC ref 3741.
  - Sixteen Items of correspondence with comments, circulated to Commissioners for consideration. A detailed discussion took place and it was unanimously Resolved to approve planning application 16/00035/B and include a request that the proposed bridge railings are a bespoke design, incorporating panels depicting scenes around village.
- **Planning Application No 16/00049/B** of 18.01.16 in respect of installation of a replacement door and side window to dwelling at Harbour View, Back Shore Road, Laxey, IM4 7DQ. [LVC Ref: 3742]. It was Resolved to approve planning application 16/00049/B.
