- **Municipal Association** RB reported Richard Pearson Director of Highways, Department of Infrastructure had been in attendance. Richard had spoken to the meeting about highway maintenance budgets and proposed legislation which would give powers to seize vehicles in relation to unpaid parking fines. Also a new bill was current being processed through the system which introduces new offences of causing death by reckless driving and careless driving; this will be in place August 2012. Mr Pearson also talked about overhanging trees and un-adopted roads. Roads can be adopted by the department if they meet the relevant standards and grants up to 50% are available to bring roads up to the required standard.
