- b) The Minister has approved a 14% increase in disposal charges from 01.04.11 which means that the cost will rise from £30.74 to £35.00. *Noted.*
- c) Tony East of the Vintage Motor Cycle club telephones reference the annual Club meeting on Laxey Promenade during MGP. For 2012 they would like to bring over the "Jumblers", these are hobby traders who sell old bike parts etc and travel round all the major Vintage motorcycle events. He proposes to put them on the Prom Green, it will be like a small table top sale. Tony is also speaking to the Chairman of Laxey Trader and Inspector Mark Britton. *Approved.*
- d) Isle of Man Water & Sewerage Authority Annual Report and Accounts for 2010 to 2011. Noted.
 e) Approval has been granted by the Planning Department to locate a Recycling Node in Mines Road. The location needs to be agreed and there are two options. (1). Road level in hatched area, or (2) Raised area on DCL MER Land. Advise Waste Management of your preference. (Their preference is (1). See additional correspondence between Highways and Infrastructure.

- a) Julie Pinson telephones on 02.12.11, requesting permission to borrow Santa's Grotto from the Commissioners for use at the Corn Mill on Saturday's 10.12.11 and 17.12.11. *Approved.*
- b) Willoughby e-mails at 1445 hours on 05.12.11 the following message from Treasury regarding Local Authority Lending. "Following on from the recent change to the Island's Standard and Poors rating to AA+, the Isle of Man Bank has applied an extra 25 basis points (0.25%) to all Local Authority loans outstanding to be implemented wef 23rd December, 2011. This is in accordance with the current terms and conditions of the agreement between Treasury and Isle of Man Bank. Existing loans will be affected as their quarterly interest calculation falls due and loans roll forward. In order to maintain an element of flexibility into the future, the Treasury has determined that it will only sanction borrowing petitions or provide letters of comfort under this facility in cases where the loan agreement is in accordance with the "Overdraft" or "Variable Rate" terms and conditions available within this facility. Treasury, as guarantors for the Local Authority lending facility, has determined that all new loans taken by Local Authorities for capital finance shall be executed under the variable loan terms and conditions available from Isle of Man Bank. This direction from Treasury will apply with immediate effect and will apply to any borrowing petitions or loan agreements entered into with effect from 1st December 2011. If you have any matters of policy that you would like to raise, could you please direct these to Clive McGreal, Financial Controller at the Treasury." Noted.
- c) Cara at MEA e-mails at 1632 hours on 05.12.11 to say that the engineer attended Lamp LA097 outside 45 Ard Reayrt to replace lamp but found that since his last inspection the column has been damaged by a third party and is in need of replacement at a cost of £2949.00 + VAT.
