a) Planning Department letter of 04.09.12, further to their 27.06.12 regarding Local Authority User Group Meetings. b) David Miller of Dalrymples emails on 07.09.12 in respect of the Mines Road Coach Park scheme and Commissioners proposals for out of season use by other Vehicles and yellow hatched lines. DM states he would be concerned that, as the area would presumably only be marked out for coaches, parking by other vehicles would be indiscriminate and random. This would probably result in this prominent area being as unattractive as it currently is out of season. The area could of course be painted with yellow hatched lines but I, for aesthetic and clarity reasons, would prefer that this wasn't done.

I agree with David Miller comments [see minute ref 69/12, item b)], and that coating the new coach stop area with yellow paint and/or making it an off season parking area (that would quickly fill up with campervans!) would be completely detrimental to what is trying to be achieved at this location.
 - 2. I would like to attend the Tours Isle of Man coach trial. Please let me know when? Also, I am chasing the order to re-mark the double yellow lines that previously existed from the box marking to the entrance to what used to be "Browns Café".
 - 3. The parking area opposite the houses is currently a "free for all", consideration needs to be given to creating daytime limited/seasonal parking (Police support would be needed)? This would get rid of the "long-term" parking that currently takes up valuable visitor parking when it is needed most? I would propose that parking along the road on the houses side remains primarily for residents use (though this cannot be marked as such)
