Planning Applications

Planning Application No 12/00749/B of 18.05.12 in respect of erection of six dwellings with parking to replace existing Public House at The New Inn, New Road, Laxey. [LVC Ref: 3583].
Letter of objection received.

The Board recommends refusal of the above application on the grounds that:-

1. The proposed development is over intensive for the size of the site, 4 or 5 properties would sit more comfortably on the footprint.

2. The two properties with the end gables facing New Road are not in keeping with the traditional "Manx cottage" style of building, and therefore would have a detrimental impact on the street scene.

The letter particularly thanks the Clerk, Mr Burgess, for his substantial contribution in the organisation of the event which reflects well on the Commissioners and Village as a whole. *SJ reported she had been on Laxey Station when the Torch arrived on the Tram and had welcomed the Torch bearer on behalf of the Local Authority. Noted.*

32/12 Any Other Business

- a) Noah's Ark Nursery request permission to use the Promenade Green for their sports day Thursday 28th June between 10 and 11am. *Noted, Approved*.
- b) Link Bus signs Funding for larger signs required. The Clerk advised that representatives from the regeneration Committee had met on Monday 18.06.12 for a press photo at the wheel car park and observations were made in respect of the size of the link bus signs and they were not viable enough.. Clerk sated quotes had been obtained and funding of £140 was required to purchase the larger signs. Resolved That the larger signs are purchased and erected as soon as possible. Proposed PK, Seconded AM.
- c) Richard Henthorn emails dated 18.06.12 on behalf of the WMI Management Committee seeking waiving the village rate for the WMI or the Commissioners making a financial contribution towards. *The Clerk advised the rate charges for the WMI was £456.63, and t as the Authorities rates were collected by Treasury we had to abele by there rules, which state rates reductions can only be applied if the rentals income is from a Charitable organisation and for none profit making purposes, at present the majority of the WMI income comes from private and commercial bookings. PK stated he did not agree with this request. (Note some Local Authorities collect there own rates and can apply there own discounts or waivers).*

[PK apologised and left the meeting at 7.50pm].

A discussion took place and the Commissioners resolved the Clerk write to the WMI and advise they were unable to assist with this request at this time.

- d) PK emails 1446hrs on 20.06.12 at 1445hrs in respect of various works for the attention of the Department of Infrastructure. *Clerk to forward to relevant DoI officers*.
- e) RB reported there was a scaffolding pole in the river adjacent to Cooil Roi. *Clerk to contact DoI*.
