- d) Grass Cutting by Lonan Commissioners on Department of Infrastructure Land. In order to make savings the Department is only prepared to pay for four cuts per year. We are contracted to make eight cuts per year. This means that the Authority will have to subsidise the Department. A discussion took place and it was resolved that with regret they would have to accept the situation and pay the difference.

- k) Local resident writes to complain about anti-social behaviour caused by horse riders in Croit-e-Quill Road, and environs, with the depositing of horse excreta. Complainant accepts that they live in a semi-rural area but this does not excuse this in an urban one. Given that the horses are walked regularly from the Ménage at Strenaby, it would not be unreasonable to have a policy of clearing up after the daily walking of the horses. There are alternative solutions. The Clerk informed the meeting that the complainant had spoken to some riders since writing to the Board and had met with abuse and subsequently witnessed the horses galloping in Croit-e-Quill Road. A discussion took place and it was agreed that a letter should be sent to the proprietors asking them to encourage their clients to be more thoughtful and consider picking up any excreta. The Clerk further raised the matter of the plastic fence in Croit-e-Quill Road that had been erected illegally and for which approval was refused at an Appeal Hearing. The Clerk was directed to contact the Enforcement Officer to find out why no action had been taken.
