- e) Road Races Bill 2015 Consultation Good afternoon everyone, The Department of Infrastructure is seeking to update key elements of legislation to ensure that motorsport festivals continue to flourish and make an important contribution to the Island's economy and culture. The Road Races Bill 2015 aims to better reflect the needs of event organisers, participants and fans by reducing bureaucracy, enhancing safety and increasing the period over which road racing can take place. Details of how to respond to the consultation can be found in the consultation document. *Noted*.
- f) Consultation on the proposed Establishment of a separate Financial Intelligence Unit for the Isle of Man Good Afternoon, The Cabinet Office is seeking views on the proposed establishment of an independent Financial Intelligence Unit, with enhanced information gathering powers. The current Financial Intelligence Unit sits within the Financial Crimes Unit, the changes proposed in the Financial Intelligence Bill, will put the unit on the same footing as those in other jurisdictions and enable it to meet its international obligations.
