# 58/14 Minutes of the Parish Inspection Meeting of 10<sup>th</sup> September 2014.

## 59/14 Matters Arising out of the Minutes.

- a) PH 49/14(c) informed the Board that the bushes had been cut back, that the two defective benches had been replaced and that the tree near the clock was alive and well.
- b) SC 49/14(d) Asked if the householders on reduced rates were now paying the full amount as the building works had ceased. **PH** stated that he was awaiting confirmation, but would speak to the Department again.

- c) SC 49/14(f) informed the Board that he had attended the NTMLG and all of the matters raised at Ballaragh were going to be looked at and also the matter of the pedestrian crossing request at Church Road/Pinfold Hill. (MB also attended this meeting).

#### 61/14 Matters Arising out of the Minutes.

- a) SC 51/14(a) Stated that at the Civic Service the Vicar had questioned why their noticeboard had been removed from Church Road. **PH** advised the Board that the noticeboard was not the property of the Church, but had been erected as a good will gesture by the previous Board. A discussion took place as to whether it should be restored and replaced, or a new noticeboard be purchased. The Clerk was tasked to produce the noticeboard at the next meeting and research alternative solutions.
- b) SC 51/14(b) Thanked everyone for their assistance and attendance at the Civic Service.
- c) SC 52/14(e) Stated that he had examined the basis that the Garff Refuse split had been calculated to understand why Lonan was paying more. He appraised the Board and a discussion took place.

ND arrived at 0940 hours.

d) SC – 54/14(e) – Asked the Clerk if the Contract was being progressed to which PH confirmed that he had spoken to the Contractor who was happy with the agreement.

- e) SC 54/14(k) Asked if this problem had been resolved. **PH** informed the Board that he had attended the Riding Establishment and whilst they took the view that we live in the countryside, etc they were concerned about horse riders galloping on the public highway. They pointed out that there were other riding establishments in the area. He added that he had written to the complainant.
- f) SEC 57/14(a) Asked about the expenses issue at Cooil Roi, to which ND explained that it had been agreed that Board Member expenses would be paid by Cooil Roi as opposed to this Authority.

## 63/14 Planning Applications.

- Planning Application No 14/01135/B of 30.09.14 in respect of variation of condition 1 of approved PA 12/01254/B to retain marquee and extend time of period of permission. (All applications in respect of this development, which was erected without permission, have been opposed by Lonan Parish Commissioners). The Clerk explained the history behind this application and a discussion took place. The majority agreed that there had been no change in circumstances that would alter their position and recommended that the application should be refused on the grounds that, it dominates the existing dwelling and is a visual scar on the surrounding countryside when viewed from the main road and beyond which is not screened by trees; Continued approval of a temporary structure could allow the applicants to argue the case for a permanent structure as originally applied for and refused. SEC asked to be excluded from this recommendation.
- Planning Application No 14/01137/B of 30.09.14 in respect of erection of a workshop/garage/store building at Field 613057, Ballamenagh Moar Farm, Ballamenagh Road, Baldrine, IM4 6AJ. The Board recommended refusal on the grounds that the building is intended for agricultural use and the application should clearly state that; the building should be located near existing agricultural buildings as distinct from a location next to residential dwelling; the plans do not provide enough detail as to finish, style or appearance and impact on the local visual amenity, making an informed decision impossible. SEC declared an interest and took no part in the discussions.
- c) Copy of letter from Planning Department to Kay Associates in respect of Planning Application No 13/91534/B of 24.12.13 in respect of erection of a replacement dwelling with garage block and remedial work to existing barn and outbuilding at Baldromma Christian, Ballamenagh Road, Baldrine, IM4 6AG. It states that the contents of their letter were discussed at a meeting on 9<sup>th</sup> October, and that they happy that the completion of works is in accordance with the Schedule of External Finishes as set out in their letter of 28<sup>th</sup> May 2014. It is sufficient to satisfy the requirements of Condition 3 of the above approval. *The Clerk stated that they had not been provided with copies of the described correspondence and the matter was noted*.
- d) Planning Application No 14/01187/B of 10.10.14 in respect of erection of a replacement dwelling at Eskadale, King Edward Road, Onchan, IM4 6AB. (See also approved 09/01722/B & 11/00204/B).
