- b) Manx National Heritage letter of 20.04.12 regarding Consultation on John Donald Collister Bequest of £635,000.00 plus land and dormer bungalow in Colby. The Consultation seeks views as to how this gift should be used. The Board discussed this matter and believed that there was a general consensus that the bequest should remain in the South. No submission to be made.
- c) Grainne Burns, Youth Officer, writes with regards to a consultation session with its members to look at issues to do with running the Youth Club. The young people in the age range 12-16 were asked for their views. Most, if not all of these views related to Laxey and in particular the skate park and raft. Typically they would like better shops, but interestingly free Wi-Fi was mentioned as well as cinema, swimming pool etc. Grianne would welcome the Commissioners to talk to the youths who have responded. *ND* read the letter to the Board and a discussion took place from which it was decided that the best option to examine was the provision of free Wi-Fi in the Village. To that end they agreed that if Laxey Commissioners considered this to be a viable option then Lonan would share the costs. Clerk to write to the Board of Laxey Commissioners.
- Resident of Croit-e-Quill Road attends at 1050 hours with copy of Enforcement letter of 12.04.12 stating that there are no enforceable matters in relation to the Heritage Homes Site in respect of the mound of soil. This matter was discussed at length and it was agreed that as with the letter at 22/12(e)below the residents should be written to by the Clerk to assure them that they were as equally concerned about the issue and would do everything possible to see this matter properly addressed.
- e) Resident of Croit-e-Quill Road, Lonan, IM4 7JH copies her letter of 16.05.12 to Planning Enforcement Officer regarding the intolerable situation caused by the spoil heap being left by Heritage Homes during their construction of Phase 2. Despite numerous complaints both from residents and Steve Rodan alike they have declined to do anything about it.

- f) Building Control (Amendment) Act 2011 Dangerous & Ruinous Buildings. SCL opened the discussion regarding a number of dwellings in Lonan that were particularly unsightly and directly referred to two in particular being Baldrine Lodge, Main Road, Baldrine and Green Gables, Laxey Road, Baldrine. PH re-stated the relevant laws explaining that the actions were time based and specific. Whilst agreeing that a non-confrontational approach was usually the best way forward, there was no scope for this as it could compromise the due process of law if subsequently challenged that the procedures had not been followed accurately. SC proposed that the Clerk be directed to instigate an informal approach at the outset to see how this progressed. The proposal was seconded by JF and unanimously agreed. PH further informed the Board that with regards to Baldrine Lodge he had been in contact with a neighbour and had tried to pursue the identity of the owner by reference to his car registration number but this had not been fruitful due to disclosure issues surrounding the Data Protection Act, but he would try again. SCL mentioned a hedge in Baldrine Road that he believed was restricting visibility and PH advised him that he was
