12.73. Consideration of the accuracy of the Minutes of the Meeting of the 2nd of April 2012.

Reference was made to other activities being planned involving the school and support for an event being organised by Maughold Social Club. 12/00476/B **Thie y Chleree, Maughold Village,** Demolition of existing rear extension and erection of a replacement 2 storey extension including erection of a detached double garage.

Some concerns regarding intrusion into the landscape of the new build double garage were raised and discussed. It was agreed that consideration of these aspects should be deferred to the Conservation and Planning Officers. It was noted that access to the public toilets was needed at all times. However, it was noted that there were no indications in the plans that this access would be affected.

12/00571/B **Shan Vallah**, The Colony, Alterations, erection of extensions to side and rear elevations and installation of roof lights and dormer window to dwelling.

Concerns were raised with this application. These being: over-intensive use of the plot when percolation in the immediate area was known to be poor; that the large extension would 'un-balance' the visual appearance of the semi-detached block. These concerns to be included in the submission to the Planning Officer.
