The Minutes of the Statutory Meeting of 21st June 2011 were examined for accuracy, and it was agreed that they represented a correct statement of events.

28/11 Matters Arising out of the Minutes.

- a) ND 20/11(b) Stated that the potholes still had not been repaired despite approaches to the Department. PH stated that he had contacted them and would do so again.
- b) SC 23/11(j) Asked what assistance had been requested to which PH replied that no assistance was required, it was for information only.
- c) JF 23/11(I) Stated that he had attended the Northern Traffic Management Liaison Group Meeting and had raised the concerns expressed. They have undertaken to review the matter regarding the Bus Stop.
- **BB** 23/11(i) Updated the Board regarding the recent ECAS Meeting and confirmed that the next meeting would be on Monday 25th July 2011 at 2.00 pm at the Strathallan Suite. **PH** referred to an email received today in which a request had been made to establish from the Members their views about frequency, attendance and method of communication in respect of the Committee. A discussion took place and it was proposed that the meetings should be quarterly, any member should attend as well as the Clerk and communication should be to the Commissioners' Office.
- e) SC 26/11(a) Considered that the cost of the unit was high and this view was echoed by the other Members. PH explained that the current sign at Church Road had cost approximately £500.00 some six years ago and was not in particularly good condition now. He added that realistically to replace this with like for like would probably now cost nearer £1000.00 and the value of this stand-alone, galvanised, painted steel unit, that had longevity and good appearance would seem to be good value. SC asked if a substantial discount could be obtained by purchasing two units, one of which could replace the Church Road Board. A full discussion took place at the conclusion of which it was determined that they would go ahead with the purchase of the stand-alone unit for Baldrine Park.
